NOTE:

- 1. If the loaded transport arrangement height exceeds:
 - 4.15 metres (13.5 ft.) Form 10 Approval of Utility Companies <u>must</u> be signed by applicable Telephone and Cable T.V. company and accompany this application.
 - 4.30 metres (14.1 feet) Form 10 Approval of Hydro Utility Companies <u>must</u> be signed by applicable Hydro Utility (Hydro One or Bluewater Power) and accompany this application.
- 2. A Private Escort Service is required when load width is 3.76 metres to 4.99 metres. For loads in excess of 4.99 metres wide, a Certified Superload Escort is required. It is the applicant's responsibility to arrange for the escort if it is required and the Escort Certificate must be provided and attached to the permit application form (Form 10). Please note that local police escorts may be required along County of Lambton Roads in the City of Sarnia.
- 3. No Permit will be issued until the proper permit fee and deposit have been paid to the County (cheques payable to "County of Lambton").
- 4. Any persons found to be in violation of any provision of a moving permit is guilty of an offence and is subject to such fine or penalty as may be permitted under the Highway Traffic Act, as amended.
