#### New Buildings

New Residential: additions, alterations resulting in the creation of additional units or building area:

1) Single Family	\$400.00 plus \$0.45 per square foot
2) Duplex, semi-detached	\$400.00 per unit plus \$0.45 per square foot
3) Row, Cluster, Condominiums, Apartments	\$400.00 per unit plus \$0.45 per square foot
New Farm Buildings, and accessory structures	\$100.00 per permit under 250 square feet
	\$300.00 per permit between 250 and 750 square feet
	\$400.00 per permit between 750 square feet and 1,500 square feet
	\$600.00 per permit over 1500 square feet

#### New Commercial, Institutional, Industrial and Additions

Includes basements and storage areas	\$100.00 plus \$6.00 per \$1,000.00 of the estimated cost of construction

#### Solar Panels

A separate building permit is required for a solar panel where the face area is equal to or greater than 5 square metres	\$600.00

#### Wind Turbines

A structure that supports a wind turbine generator having a rated output greater than 3kW	\$14,000.00

#### Alterations/Renovations

Alterations, renovations, additions to existing buildings and other buildings not named above	\$200.00 plus \$6.00 per \$1,000.00 estimated cost of construction

### **Building Relocation**

Permit to move or relocate a building	\$100.00 plus traveling costs incurred for Inspection prior to the movement of the building
Permit to move or relocate a building	\$400.00 plus \$0.45 per square foot
Deposits required to move a building	\$1,000.00 refundable
Fee for moving a building on Township Roads	\$100.00 non-refundable
Deposit required to move or locate a dwelling unit on a property in Enniskillen Township	\$7,500.00 refundable

### **Note:**

1. Alteration Renovation costs above are in addition to the Building Relocation costs.
2. Required Insurance - Minimum of \$1,000,000.00

### **Demolition Permits**

Residential dwelling or commercial Building	\$100.00
---	----------

### **Other**

1. Swimming Pool Fence \$50.00
2. Commercial Tents and temporary structures \$50.00
3. Change of Use Permit \$50.00
  - when a change of use increases the hazard in the premises

### **Notes:**

A permit is not required where the repair or alterations to any existing building does not exceed \$1,000.00 in costs, unless structural timbers are cut, existing stairways are closed or new stairways opened, exits from buildings are altered or steps, and/or concrete, brick or masonry walls are cut away. Where no permit is required, all such repairs/alterations must comply with the intent of this bylaw and satisfactory to the building inspector, unless written exemption is provided by the building inspector to obtain a permit.

No permit is required for roofing, shingling, eavestroughing, soffit and fascia.
