

# County of Lambton Affordable and Supportive Housing Strategic Development Plan

August 11, 2025





- 2,490 net new affordable housing units are required to meet the needs of the community
- 1,008 households are currently on the centralized waiting list for housing
  - 973 households (96.5%) on the waitlist are for Sarnia.
- 294 individuals are on the By-Name List
  - 207 households (70.4%) are experiencing chronic homelessness



## Housing and Homelessness Plan

■ June 2020 County Council approved the Housing and Homelessness Plan 5-Year Review which included the following goal:

## Goal 2 – Increase access to affordable housing and supports that meet people's needs to achieve housing stability.

This Plan included a comprehensive community engagement strategy that was undertaken through 2019.

March 21, 2023, the Housing, Homelessness, and Addiction Summit was held. Over 170 participants attended the summit and identified the 'Development of affordable and supportive housing' as a top priority





July 2023 Lambton County Council endorsed the following motion:

## Bradley/White:

That County Council publicly endorse making affordable housing and shelter the number one priority of County Council.

October 2023 Flourish was engaged to assist in developing a strategic plan for <u>affordable and supportive</u> housing.



## **Housing Plan**

■ February 2024 the strategic development plan ("Housing Plan") for affordable and supportive housing was endorsed by County Council:

### Bradley/Dennis:

#### That Staff be directed to:

- (1) pursue the projects listed in the Supportive and Affordable Housing Strategic Development Plan ("Plan"),
- (2) seek upper-level financial support therefore, and
- (3) seek further instructions and authorizations from County Council on a project by project basis, with the goal of completing one of the projects outlined in the Plan preferably within 18 months, to the extent reasonably possible.





## The Housing Plan included the following project recommendations:

- March 2024 County Council approved the issuance of a Request for Proposal for a Supportive Housing Agency partnership to advance the recommendations contained in the Housing Plan.
- April 2024 County Council approval of 50-unit affordable housing development on Kathleen Ave.
- May 2024 members of County of Lambton senior management presented to City of Sarnia Council regarding Homelessness Response and Future Plans for Affordable & Supportive Housing.





- May 2024 County Council approved the acquisition of the Cathcart Blvd property identified as Project B in the Housing Plan.
- June 2024 the City and County jointly hosted a public virtual Housing and Homelessness Townhall session. This session addressed questions and concerns regarding housing and homelessness in the community.
- June 2024 Indwell Community Homes ("Indwell") was the successful Supportive Housing Agency under the March 2024 Request for Proposal and a partnership was formed with the goal to plan, construct and operate between 150 and 300 supportive housing units in Lambton.





- September 2024 Housing and Homelessness Community Forum was held at the Dante Club. The County presented its plans, and the public was provided the opportunity to express their concerns and suggest solutions.
- February 2025 County Council considered the vacant land beside the George Street EMS station as potential donation to Indwell for their development of supportive housing in Lambton.
- May 2025 County Council approved the donation of the George Street property to Indwell for their development of supportive housing, in line with the County's Indwell partnership and the Housing Plan.





May 2025 County Council reaffirmed its commitment to affordable housing and further added supportive housing by endorsing the following motion:

#### McRoberts/Cook:

That County Council publicly endorse making affordable and supportive housing and shelter the number one priority of County Council.

■ June 2025 County Council received an update from Indwell on the partnership.





■ June 2025 the County's Housing Plan update to address affordable and supportive housing was endorsed by County Council and included the following project recommendations.

## **Housing Plan - Summary**

Comprehensive Housing Plan developed and actioned with approval of County Council after broad community input.

### **Housing Plan:**

- 2 new County housing projects currently under construction
- Acquisition of lands for future development
- Addition of supportive/affordable housing units to current building assets
- Grant funding to 3<sup>rd</sup> party community partners for affordable and supportive housing
- Donation of lands to 3<sup>rd</sup> party(ies) for affordable/supportive housing



## **Housing Plan – Indwell Donation**

- George St. lands donated to Indwell on May 7th for affordable and supportive housing, after those lands were identified in May 2023, and included in Housing Plan in February 2024, for those purposes
- Indwell is landowner and proponent of proposed affordable and supportive housing development
